A meeting of the Board was held on Thursday, January 16, 2020 at the Central Branch.

1. Call to Order

Lita Barrie, CEO, called the meeting to order at 6:54 p.m.

2. Approval of the Agenda

Motion 20-01, Approval of the Agenda

MOVED by Catharine Benzie, SECONDED by Bianca Tse, that the agenda be approved as presented. CARRIED.

4. Election of Chair and Vice Chair

4.1. Report of the Nominating Committee
